1. ***Tokha Municipality, Office of the Municipal Executive, Maijehity, Kathmandu, Nepal*** invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of ***Construction of Tokha Mul Sadak at Ward No. 2*** under National Competitive Bidding procedures. The estimated amount for the works is **Rs 19286579.27 inclusive VAT**.

Bidder must submit their bid electronically and may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at ***Tokha Municipality, Office of the Municipal Executive, Maijehity, Kathmandu, Nepal*** at ***31 January, 2020; 11 AM***.
5. Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before ***12 noon*** on ***11 February, 2020***. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at ***1 PM*** on ***11 February, 2020*** at ***Tokha Municipality, Office of the Municipal Executive, Maijehity, Kathmandu, Nepal***. Bids must be valid for a period of ***90 days*** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NPR 4,70,000 (Four Lakhs Seventy Thousand Rupees only), which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
